**Description**

Borcycle™ AH1040MO-90 is a recycled PP solution with post-consumer recycle (PCR) content above 96.5%.

It is made from post-consumer plastic waste which undergoes processing steps such as sorting, shredding, washing, drying, extrusion (including melt filtration, at a level of 110 microns) and pelletizing, resulting in a circular polypropylene grade with minimum PP content above 90%. The material is sold in pellet form.

Borcycle™ AH1040MO-90 is intended for injection moulding. “-90” refers to the colour version of the product, a visual indication of “white”. Due to the nature of recyclates, some variation in colour can be observed between batches.

The product is not intended for use in beverages, drinking water contact, food contact, medical, pharmaceutical or healthcare applications.

Borcycle™ AH1040MO-90 is compliant with EN15343:2007 and UNI 10667-3.

Processing setting	Typical value/range
Melt temperature	210 - 260 °C
Holding pressure	200 - 500 bar
Mould temperature	30- 40 °C
Injection speed	high bar

Shrinkage 1 - 2 %, depending on wall thickness and moulding parameters

AH1040MO-90 should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation, which can result in odour generation and colour changes and can have negative effects on the physical properties of this product.
