Processing techniques

This product is easy to process with standard injection moulding machines. Following parameters should be used as guidelines:

The actual conditions will depend on the type of equipment used.

Packaging and storage

EE050AE should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation, which can result in odour generation and colour changes and can have negative effects on the physical properties of this product.
