#### **Processing Techniques**

The actual conditions will depend on the type of equipment used.

FR1126MOB is easy to process with standard injection moulding machines. Following moulding parameters should be used as guidelines: To avoid residual humidity from transport or storage, the material should be pre-dried approximately 2h at  $95^{\circ}$  -  $105^{\circ}$ C.
