Packaging and storage

BorSafe HE3490-LS shall be stored indoors below 50°C in unopened original packaging in clean and dry environment. It is recommended to ensure proper stock rotation by using first in - first out principle. Following afore-mentioned conditions the material can safely be stored for a period of up to 2 years after production. However, caution shall be taken regarding the moisture level. It is recommended to measure the moisture after longer storage periods prior to processing.
