#### **Processing techniques**

NAV117 can be easily processed with conventional injection moulding machines. Following parameters should be used as guideline:

Processing setting	Typical value/range
Melt temperature	160 - 190 °C
Holding pressure	200 - 500 bar
Mould temperature	30 - 40 °C
Shrinkage <sup>2</sup>	1 - 2 %

### Packaging and storage

NAV117 should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation, which can result in odour generation and colour changes and can have negative effects on the physical properties of this product.
