Description

Recleo PE S3007 is a mixed-colored low density polyethylene post-consumer recyclate (rLDPE) supplied in pellet form for blown film applications. It is an ideal LDPE used where sustainability and circularity matter. Recleo PE S3007 is a post-consumer recyclate including a large part of recycled post-consumer plastic waste coming from pre-sorted municipal (household) waste. Recleo PE S3007 is part of the RecyClass certificate. Due to the nature of recyclates, some variation in color can be observed between batches.

Processing setting	Typical value/range
Melt temperature	160 - 190 °C

Due to differences in screw and die head designs the optimum temperature adjustments are individual and should be evaluated for each production line.

Processing techniques

Recleo PE S3007 is easily processed on conventional extruders. Following extrusion parameters should be used as guideline:

Packaging and storage

Recleo" PE S3007 should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation, which can result in odor generation and color changes and can have negative effects on the physical properties of this product. The shelf life is a maximum of one year after production. It can be extended after selected material properties are being retested to meet the product specifications. It is recommended to measure the moisture after longer storage periods prior to processing.
