Daplen EJ107AEB is easy to process with standard injection moulding machines. To avoid residual humidity from transport or storage, the material should be pre-dried approximately 2h at 95° - 105°C. Following parameters should be used as guidelines:

Melt temperature Holding pressure

Mould temperature Injection speed 200 - 240 °C 50-70% of injection pressure 20 - 40 °C Low to medium

#### Storage

**Daplen EJ107AEB** should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation, which results in odour generation and colour changes and can have negative effects on the physical properties of this product.
