Processing Techniques

The actual conditions will depend on the type of equipment used.

This product is easy to process with standard injection moulding machines. To avoid residual humidity from transport or storage, the material should be pre-dried approximately 2h at 95° - 105° C. Following moulding parameters should be used as guidelines:

Melt temperature	200 - 240 °C
Holding pressure	50-70% of injection pressure
Mould temperature	40 - 80 °C
Screw speed	Low to medium
Injection speed	Medium to high

Storage

Fibremod GC420SFB should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation, which results in odour generation and colour changes and can have negative effects on the physical properties of this product.
