1. Identification of the substance/mixture and of the company/undertaking

2. Hazards identification

Classification of the substance or mixture

The product is not classified as hazardous according to Regulation (EC) No 1272/2008 and its amendments.

Label elements

Not a hazardous substance or mixture. No hazard pictogram, no signal word, no hazard statement(s), no precautionary statement(s) required.

Other hazards

The product burns, but is not classified as flammable. Dust from the product gives a potential risk for dust explosion. May form combustible dust - air mixtures. This substance/mixture contains no components considered to be either persistent, bioaccumulative and toxic (PBT), or very persistent and very bioaccumulative (vPvB) at levels of 0.1% or higher. The substance/mixture does not contain components considered to have endocrine disrupting properties according to REACH Article 57(f) or Commission Delegated regulation (EU) 2017/2100 or Commission Regulation (EU) 2018/605 at levels of 0.1% or higher.

3. Composition/information on ingredients

The product is a polyethylene polymer.

Contains no substance classified as hazardous in concentrations, which should be taken into account according to EU regulations.

4. First aid measures

If inhaled: Move to fresh air in case of accidental inhalation of vapors or decomposition products.

In case of skin contact: If molten material comes in contact with the skin, cool with plenty of water. DO NOT remove solidified product, as removal could result in severe tissue damage. Obtain medical attention.

Most important symptoms and effects, both acute and delayed:

Inhalation of dust may irritate the respiratory tract. Prolonged inhalation of high doses of decomposition products may give headache or irritation of the respiratory tract.

5. Fire-fighting measures

Suitable extinguishing media: Water in spread jet, dry chemicals, foam or carbon dioxide.

Specific hazards during fire fighting: Principal toxicant in the smoke is carbon monoxide.

Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.

6. Accidental release measures

Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration.

Vacuum or sweep up spill. All spill of material must be removed immediately to prevent slipping accidents. Recycle or dispose loose material properly. Do not flush into surface water or sanitary sewer system. Should not be released into the environment.

It is recommended to implement systems and practices (such as Operation Clean Sweep®) to prevent accidental release of plastics in to the environment.

7. Handling and storage

Advice on safe handling: During processing and thermal treatment of the product, small amounts of volatile hydrocarbons may be released. Avoid inhalation of dust and decomposition fumes. Provide adequate ventilation. Local exhaust ventilation or additional personal protective equipment (PPE) may be necessary.

Storage: On places where bagged products are stored control of ignition sources shall be implemented because big quantities represent a big combustible load. For storage in silo's equipment needs to be properly earthed to prevent static electricity.

8. Exposure controls/personal protection

Do not eat, drink or smoke when using this product. Wash hands before breaks and at the end of workday.

9. Physical and chemical properties

Appearance: powder, natural color

Odor: odorless

Melting point/ range: 100 - 140 °C

Density: 0,9 - 1,0 g/cm³

Ignition temperature: > 320 °C

Water solubility: insoluble in water

10. Stability and reactivity

The product is a stable thermoplastic, with no chemical reactivity.

11. Toxicological information

The product is not classified as hazardous to human health.

12. Ecological information

The product is not considered hazardous for the environment. Not readily biodegradable. Does not accumulate in organisms. Avoid release to the environment.

13. Disposal considerations

Reuse or recycle if not contaminated. The product may be safely used as fuel. Proper combustion does not require any special flue gas control. Check with local regulations. Discharge into the environment must be avoided.

14. Transport information

The product is not regulated by ADR/RID, IMDG or IATA.

15. Regulatory information

The synthetic polymer microparticles supplied is subject to conditions laid down by entry 78 of Annex XVII to Regulation (EC) No 1907/2006 of the European Parliament and of the Council.
