## Description

OE5318I is a copolymer of ethylene and vinyl acetate containing 18% vinyl acetate by weight.

## Applications

OE5318I is intended for use in industrial applications but shall not be used for packaging.

## Processing techniques

OE5318I copolymer shows excellent thermal stability, which allows higher processing temperatures, if needed. Additional stabilization could be required for longer exposure times. Corrosion-protected barrels, screws adapters and dies are recommended, since, at sustained melt temperatures above 230°C ethylene vinyl acetate resins may thermally degrade and release corrosive by-products.

## Packaging and storage

OE5318I should be stored at ambient room temperature and protected from UV-light. Improper storage can initiate degradation, which results in odour generation and colour changes and can have negative effects on the physical properties of this product.
