OE5325I is a copolymer of ethylene and vinyl acetate containing 25% vinyl acetate by weight.

Applications

OE5325I is intended for use in industrial applications but shall not be used for packaging.

Processing techniques

OE5325I shows excellent thermal stability, which allows higher processing temperatures, if needed. Additional stabilization could be required for longer exposure times. Corrosion-protected barrels, screws adapters and dies are recommended, since, at sustained melt temperatures above 230°C ethylene vinyl acetate resins may thermally degrade and release corrosive by-products.

Packaging and storage

OE5325I should be stored in dry conditions at ambient room temperature and protected from UV-light. Improper storage can initiate degradation, which can result in odour generation and colour changes and can have negative effects on the physical properties of this product.
